Are there services covered before you meet your deductible ?	Yes. Tier 1 and Tier 2: preventive care services are covered before you meet your deductible . Tier III: children's routine eye exams and glasses are covered before you meet your deductible . For all Tiers: value prescription medications are covered before you meet your deductible .
